Literature Search Summary

A literature search was conducted in August 2011 and updated in December 2014 to identify evidence for the *ACR Appropriateness Criteria® Diffuse Large B-Cell Lymphoma* topic. Using the search strategies described above, 584 articles were found. Eighteen articles were used in the topic. Five hundred sixty six articles were not

used due to either poor study design, the articles were not relevant or generalizable to the topic, or the results were unclear, misinterpreted, or biased.

The author added 72 citations from bibliographies, websites, or books that were not found in the literature search.
